3	(a) IN GENERAL.—The Assistant Secretary of the

4 (e) STUDY.—The Secretary of the Army, in conjunc-5 tion with the National Academies of Sciences, shall undertake a study of the legacy of pollution and nutrient loading 6 7 as well as the impacts of soil amendments from current 8 and past operational regimes. The study shall include— 9 (1) the components of the nutrient load and soil 10 amendments, and how this nutrient loading is and 11 will continue to impact Everglades restoration ef-12 forts; and

13 (2) proposed solutions to ameliorate the impacts14 of this pollution to downstream watersheds.

(f) SCOPE.—Nothing in this section shall be con-strued to alter or amend—

(1) the Water Rights Compact between the
State of Florida and the Seminole Tribe of Florida;
(2) the water quality standards of the
Miccosukee Tribe of Indians of Florida;

(3) State water quality standards, applicable
National Pollutant Discharge Elimination System
discharge permits, and Everglades Forever Act watershed permits; or

(4) the schedule for completion of the Central
 Everglades Planning Project or Comprehensive Ev erglades Restoration Plan projects authorized on or
 before enactment of this Act.

5 (g) PROHIBITION ON USE OF RESTORATION
6 FUNDS.—No restoration funds shall be used by the Sec7 retary to undertake Deep Well Injection (DWI) of flood
8 or any other excess waters.

9 (h) AUTHORIZATION OF APPROPRIATIONS.—There
10 are authorized to be appropriated such sums as are nec11 essary to carry out the provisions of this Act.
